2025 Rules & Event Guidelines

Competitor Rules:

1. HAVING FUN IS MANDATORY!

2. **Safety** – The safety of the participants, spectators, staff, and competitions is the number one priority and should be treated as such for all races. **It is mandatory for all competitors wear a PFD (personal flotation device) while racing.** Please bring your own PFD.

3. Boat Design –

- A. Boats and paddles must be made **PRIOR TO THE RACE.**
- B. Boats must be made **ONLY** of cardboard, duct tape, packing tape, hot glue, rope and string.
- C. Boats may be painted with water-based paint and sealers must be dry before the board enters the water.
- D. NO fiberglass, sona-tubes, no liners, tarps or coated cardboard.
- E. Cardboard cannot be sealed with any sealants, wax, resin, vinyl coating, silicon, caulking compounds.
- F. If any illegal items used in construction are discovered during the pre- or post- race inspection, the boat will be disqualified.
- G. Boats may be a maximum width of 3' wide and maximum length of 7'.
- H. Boats must be propelled by the use of cardboard paddles.
 - i. Paddles must meet the same construction requirements as the boats.
- I. Boats must have completely enclosed side walls so that no part of the lower body is outside the boat.
- J. The boat's passenger area must not be enclosed above the occupant's shoulders so as to interfere with escape should the vessel begin to sink.
- K. Boat design is left to the builders. Let your imagination take over; make your boat look like a race car, flying saucer, dragon, etc. as long as the decoration does not aid in the floatation.
- L. Teams are not allowed to patch or alter their boat between races.
- M. Race must begin and end with 1 or 2-person crew intact.

4. **Conduct** - It is the competitor's responsibility to act in a sportsman like fashion, avoid collisions at all times and obey the rules and safety guidelines.

- a. Overly aggressive contact and/or un-sportsmen like conduct will not be tolerated and will result in disqualification as the sole discretion of event organizers. Examples include but are not limited to:
 - i. Purposely obstructing or interfering with another competitor
 - ii. Causing damage or bodily harm to another competitor
 - iii. Use of profane language toward any persons or competitor

Event Guidelines:

1. Races will run in heats and begins at approximately 10:00 a.m. Boats must be inspected prior to racing. Sign in / registration will begin at 9:00am and end by 9:45am.
2. Teams:
 - a. Teams must be a minimum of one person in the boat, but no more than 2 in a boat; and
 - b. Up to two (2) additional people are allowed at the start line to assist with boat launch.
 - c. Proper swim attire is required.
 - d. United States Coast Guard (USCG) Personal Flotation Device (PFD) is required. Life Jacket
3. Age Requirements:
 - A. 6 years old or older- must be able to swim.
 - B. No dogs
4. Race organizers will determine the winners of the following categories:
 - A. Fastest Boats (Fastest Time)
 - B. Most Dramatic Sinking- Titanic Award
 - C. Most Creative Design
 - D. Best Costume
 - E. Best Team Name
5. Entry Fees & Categories:
 - A. **\$15** – Advance registration (preferred)
 - a. *1 man and 2 man crewed boats*
 - B. **\$20** – Day of registration
 - a. *1 man and 2 man crewed boats*
 - C. **\$30** – *Challenge Category*
 - a. *Friendly Competitors Challenge- challenge someone to a private boat race and pay for your entry fee and that of the business/ entity/ person you have challenged.*
6. Prizes
 - A. First Place- Free Entry in next years race, Family 4 pack of season passes to the Amsler Park Aquatic Center & Bragging Rights – Valued at \$115
 - B. Second Place- 2 season passes to the Amsler Park Aquatic Center – Valued at \$80
6. Race Type
 - A. The race will be one length of the pool. (North to South)
 - B. Teams will be put into a **single-elimination** bracket upon registration (teams may get a bye in the first round depending on the numbers of teams that register). Everyone is guaranteed one race.
 - C. The event will be made up of rounds with up to four (4) teams racing each other at a time. Depending on the number of registrations.
 - D. Events may be divided into adult and youth categories depending upon the number of registered teams.
